

Budget Overview for the 2023-24 School Year




This chart shows the total general purpose revenue Valley Home Joint Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Valley Home Joint Elementary School District is \$2,708,494, of which \$1,984,214 is Local Control Funding Formula (LCFF), \$236,305 is other state funds, \$231,800 is local funds, and \$256,175 is federal funds. Of the \$1,984,214 in LCFF Funds, \$139,668 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


Other General Fund expenditures that are not included in the LCAP are used for salaries and benefits; books and supplies; services; operating expenditures; capital outlay; and other outgoing.

In 2023-24, Valley Home Joint Elementary School District is projecting it will receive \$139,668 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

The Valley Home Joint School District is a small, rural, progressive K-8 school district serving students and parents in a 50 square mile area in the California Central Valley at the base of the Sierra foothills. Valley Home has two school sites; one that serves students in grades kindergarten through third grade and one which serves fourth through eighth-grade students. The enrollment hovers around 174 students (averaging 33% Hispanic or Latino, 54% White & 13% other) and draws from a diverse range of socio-economic backgrounds. The diverse population includes 33% low income students and 16% English learners. The school enjoys a very stable community with values that support our many student programs. Due to the small school population, the entire scope of service identified in this plan includes all students. Support services from the Stanislaus County Office of Education include business services, internet, mail, legal, psychologist, nurse, and substitute teacher placement. The district belongs to a SELPA which supports special education services for 14 qualified students. A Valley Home School graduate will possess a sense of dignity and self-respect in having acquired the skills necessary to succeed academically and socially. Students master the skills necessary to enable them to tolerate and appreciate individual differences in others. They will master problem-solving skills which allow them to confidently and competently analyze information. Valley Home students take pride in their citizenship skills which reflect patriotism and a commitment to family, community and global responsibility. Students are encouraged to work hard at developing self-discipline, a healthy lifestyle and an intrinsic motivation to succeed.

Reflections: Successes

A big success was to be able to transition out of the pandemic and have our students and families back on campus to get excited about school and our community again.

The 2022 Dashboard identified the following areas of progress:

Our chronic absenteeism rate has decreased slightly to 24.8% and remains below the State rate of 30%. Our suspension rate is 2.4% and is below the State rate of 3.1%.

Other highlights include the following:

Adoption of the new Math curriculum. (Illustrative Math) across k-8th grades

Adoption of a new Science curriculum. (TCI) across the K-8th grades.

New Baseline Science data (CAST)

Reflections: Identified Need

A big need transitioning out of the pandemic is for intervention to really take shape for the kids to get back on track after the time away during distance learning.

The 2022 Dashboard identified the following areas for improvement:

English Language Arts Achievement is at 21.6 points below standard. Although English Learner Progress was in the high range, supporting the academic achievement of English Learners continues to be an area of need and will be an area of focus in the 2021-2024 LCAP.

Chronic Absenteeism Rate in 2018 was 5.7% and in 2022 we were at 24.8%. This is the percentage of students absent 10% (18 days) or more of the instructional days during the school year.

Math Achievement is at 55.6 points below standard.

There were no student groups with significant performance gaps.

The 2021-2024 includes three goals to address the needs of students.

Goal 1 - Conditions of Learning: Schools will increase the conditions of learning through the use of CCSS aligned instructional materials, and highly qualified teachers in a clean and safe learning environment.

Goal 2 - Student Achievement: Students' academic, language, social and emotional development will be strengthened through a broad scope of learning opportunities and appropriate instructional strategies and support.

Goal 3 - Engagement: Parents and students will be engaged partners in the education of students and the development of character traits, safety, and school connectedness.

Highlights of the LCAP from this year:

Hiring of an Intervention teacher. She is phenomenal and making great strides in the program. The school district is also now going to hire another aide for this program due to its successes.

Implementing the intervention program

Adoption of Math curriculum (Illustrative Math): The teachers all voted unanimously to adopt a new program. We have setup numerous trainings for the staff to familiarize themselves with the curriculum and delivery.

Adoption of Science curriculum (TCI): Grades 4-8th grade are all now using the same program and fully invested in delivering of the curriculum.

This all helped our district (students) in the fact that we are getting very near to all being on the same page. It has taken some time, but the staff is all vested in the curriculum and we have a good plan moving forward in supporting our students with the curriculum and its delivery. The systems are now in place in identifying our students in need and getting them that extra support needed especially after coming out of Covid and better serving our students.

Engaging Educational Partners

The following opportunities were provided to ensure a process for all educational partners to have a meaningful engagement on the development of Valley Home's LCAP: LCAP input was invited at staff meetings, collaboration meetings, ELAC, Title 1 parents, and Parent Teacher Club meetings. Both certificated and classified bargaining units were consulted and given opportunity to provide feedback on the LCAP. Input was welcomed.

The English Language Advisory Committee meetings also provide a comprehensive opportunity for our Spanish speaking parents to evaluate progress on goals and brainstorm new ideas for improvement.

Staff meetings are held at least monthly and agendas include an opportunity for staff to provide feedback on the LCAP. Staff reviews the LCAP and participates in the evaluation of goals.

Classified staff have been given a full explanation of the LCAP. Opportunities are provided to evaluate goals and propose new areas for improvement.

Families were also provided with a survey in response to proposed LCAP goals. Feedback was provided and the survey results impacted the actions that align with the 3 goals. Committees used the data from the survey to influence recommendations and modifications for goals within the LCAP.

The county SELPA was consulted as a means to gather input related to the district's special education population.

A summary of the feedback provided by specific educational partners.

Feedback from the parents included after school and before school tutoring support, review of curriculum and materials that align with state standards, social emotional support, increased hands on experiences and opportunities for students, improved communication with families regarding academic student progress, increased parent participation in school programs, and awards/incentives for academics and citizenship. We plan to continue with our intervention programs and employing para educational support.

Educational partner input has directly impacted the goals and funding within the LCAP budget. Valley Home Joint School District will receive \$139,668 LCFF Supplemental and Concentration funds based on the number and concentration of low income, foster youth and English learner students, which account for an estimated 8.32% Unduplicated Pupil Percentage. The justification for expending Supplemental and Concentration grant funds, which are principally directed toward unduplicated students, district-wide is to provide increased services to address academic, social-emotional, physical and mental health and the educational needs of Valley Home students and families. In addition, funds will provide professional learning related to specific actions and services to increase quality of educational achievement for Valley Home students. With an estimated three-fourths of our student population qualifying for additional funding, it is expected that all students will benefit from the actions supported by supplemental and concentration funds that provide professional learning related to specific actions and services to increase quality educational achievement for Valley Home students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

Services provided for unduplicated pupils will be increased by providing in class supplemental small group instruction by the classroom teacher. A paraprofessional will be available to teachers to assist with delivery of these services. Professional development and curriculum coaching will be provided during the 2023/2024 school year to better equip teachers to support unduplicated pupils. Teacher training, paraprofessional support, and tutoring are crucial to improving services for unduplicated students. The goal is to progress toward proficiency in all areas. The tutoring will help students catch up and close gaps in learning. Supplemental funds will be used to provide paraprofessional support to students. This is particularly important in the TK & K combination class and the 7th & 8th-grade combination class. Supplemental Funds will support Professional Development minimum days devoted to standards & framework review, lesson study for K-3 teachers, lesson study for 4-8 teachers and "walkthroughs" with the administration. "Lesson study" will include professional reading, demonstration lessons, lesson observations, and coaching. This activity aligns with the belief that "good first teaching" is the best way to help students who appear to be struggling to keep up with the pace of instruction.

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
