Plan Descriptions

Valley Home Joint School District addressed the expanded learning opportunities grant through staff meetings and feedback forms. The staff meeting included both classified and certificated staff from both school sites. The feedback form collect 63 responses from both English and Spanish speaking families and staff from both school sites. The goal was to come up with a plan to provide the best supplemental instruction and support to students as is possible and focused on learning loss. The needs identified in this plan include academic learning loss in reading and math, additional para support for learning loss, before school and summer school academic support, and social-emotional support. The feedback will guide the plan and will allow the district to use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for sub-groups listed above which include low-income students, homeless, students at risk of abuse, neglect, or exploitation, disengaged students, and assessed students who are below grade level.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified by using our local assessments, benchmark data, staff recommendation, and parental consultation. Our counselor from Center for Human Services and resource specialist will also play a key role in the identification of those students struggling with not only academics but social-emotional needs. It became very clear that all students need support as we transition from a year of distance learning environment to in-person instruction while recovering from the pandemic. In addition to the assessments, students will also be identified based on attendance, engagement, and social-emotional needs. Survey results from parents, students, and staff also played a large role in the identification of students and the needs specific to Valley Home.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Teachers will utilize benchmark/assessment results, data, and parent feedback to identify students who need academic and social emotional support. Students who need are below grade level will be recommended to before school and after school intervention programs for support. Additional para support will be provided for students who are not meeting grade level expectations in ELA and Math. If these intervention support systems do not improve student achievement then a student study team will be started so the staff and families can determine the best course of action that would be in the best interest of the child. During the student study team meeting, teachers will share the assessment results and the gaps in learning caused by closure and distance learning environment Valley Home Joint School District. We will not only identify students in need and share that with parents, but more importantly share resources and tools that will be utilized to improve academic/social emotional support. These conversations with parents will take place in-person, virtually, mail notification, or phone calls during the course of the year. We will also use our district communication tool to share information regarding opportunities that will support both students and parents. Continued communication with stakeholders is the key to the success of this plan.

A description of the LEA's plan to provide supplemental instruction and support.

The plan will allow the district to use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for sub-groups listed above which include low-income students, homeless, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, assessed with learning skills loss. The activities/actions were prioritized to best serve the Valley Home students. The Valley Home Joint School District will use the following tools, activities, and programs to provide the best supplemental instruction and support to all our students: Extended day is strategically offered to be inclusive and supportive of our students and families. These will be opportunities to increase the school day with both before school, summer school opportunities.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

ELO grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief funds by taking into consideration the spending deadlines for each of the respective funds. Planning in this manner allows for the services and supports designated in the ELO grant to be funded for the next two to three years, ensuring a long range plan for addressing learning loss and social emotional learning with our students. The ELO grant and other grants are being coordinated to support the hiring of an instructional aide at our school site. Coordination of the funds are also being used for additional classified hours to ensure safety precautions are implemented, ensuring our permanence in the in-person learning model.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular
 instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, EC Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals
 to provide supplemental instruction and support through the duration of this program, with a priority for full-time

paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

 An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
